FNRL NATIONAL REGISTRATION TERMS AND CONDITIONS

These terms and conditions should be read with the Fiji National Rugby League Limited's (FNRL or "the league") Privacy Policy, a copy of which is available at upon request. Capitalised terms or phrases in these terms and conditions have the same meaning as in the Privacy Policy, unless defined otherwise herein. In entering information into the FNRL's participant registration form (the Information), the Association/Club/School/League and the Participant (or if the Participant is under 18 years of age at the time of registration, that Player's parent or legal guardian) agree:

1. The Information is true, correct and accurate.
2. The Information will be held on a national database maintained by the FNRL.
3. The Information may be used and disclosed by the FNRL and the Leagues in accordance with and for the purposes specified in the FNRL's Privacy Policy, including (without limitation) processing registrations, organising, staging and conducting Competitions and providing Rugby League related information and offers from the FNRL and Rugby League Administrators.
4. The Player has voluntarily provided, in the participant registration form, some Sensitive Information relating to ethnicity and heritage. This information assists the FNRL and Rugby League Administrators to adopt a needs based approach to the administration and development of Rugby League and to ensure that it is an inclusive sport.
5. To comply with and abide by the policies of the FNRL and the Leagues including but not limited to the FNRL Rules, Code of Conduct, Laws of the Game, Rugby League Laws of Mini Footy and Mod League, Safe Play Code, FNRL Member Protection Policy, National Clearance and Permits Policy, Leagues Anti-Doping Policy, competition rules and by-laws of the League in which the Player participates and any associated rules (together, the Rules), copies of which are available upon request.

LIABILITY AND RISK

Rugby League is a body contact sport which carries a risk of personal injury. The League (herein defined to include the Fiji National Rugby League, the State Leagues, Regional Leagues, School League and/or the League in which the Participant player and/or officiates), and the Participant's Association/Club/School/League; each take steps to reduce the risk of serious injury, but it is not possible to eliminate risk in a sport involving forceful body contact. By signing this registration form, the coach/official and his parent/guardian voluntarily assume the risks associated with participating in this sport; and acknowledge this warning of the injury risks involved.

Applicable law limits the liability of the League, affiliate Leagues and their employees and officials from civil litigation arising out of injuries suffered whilst playing, or training for, rugby league.

The League dutifully expressly warns persons playing and involved in the game, and their parents and relatives, of the not insignificant risks of injury involved in the sport, and the League hereby does.

INDEMNITY AND COMPLIANCE

It is a condition of membership and/or registration with the League that the Participant and/or his parent or guardian acknowledges: -

1. That membership and/or registration is conditional on continued observance of and compliance by the Participant with the provisions of the Rules of the Game, the FNRL Policies referred to on the page hereof; the Articles, the Constitution, and the Competition Rules of the League in which the Participant participates (together, "the Rules").
2. That the Participant will accept the decisions and directions of the League and its committees made in accordance with the Rules and Regulations and the League Articles and Constitution.
3. That the Participant will not during the currency of his membership and/or registration or at any time thereafter, should he cease to be a member/registered, make any claim against the League or the Participant's League for damages in negligence or contract related to any alleged act or omission of the League, the Participant's League, the Referee's League or any of their members, officials or employees, for injury arising out of any game or training program under the control or supervision of the League or the Participant's Association/Club/School/League;
4. That in the event of any person commencing any proceedings against the Participant for any assault, breach of the Rules, or negligence; causing injury, the Participant hereby indemnifies: The League, the Participant's Association/Club/School/League, the Referee's League; and any of their officials and employees against any order of the Court including any award for damages, legal costs and disbursements which may be awarded or ordered against any of them.
5. That the indemnity and waiver herein may be pleaded in bar to any such proceedings aforesaid.
6. If the Participant shall suffer any injury including death whilst engaged in training or playing the game of rugby league and a cause of injury was the negligence, trespass, assault or a breach of other obligations imposed by laws or any of their persons or bodies named in the Rules, then the liability of the League (including its volunteers, officials and employees) is limited to the extent of any insurance policy held by the League or Participant's Association/Club/School/League; and the amount which such insurer is liable to pay under the policy, and/or the amount of insurance payable by any applicable statutory insurance schemes.
7. The Participant agrees that this limitation of liability applies even if he ceases to be a member of the League or League.
